And and then he can be a sort of additional officer in the leadership team. So that we we are we are clear that we have a good line of communication.

We're advising or we're following GDPR GDPR protocol and whatnot. So we're trying to mitigate as much potential risk as possible. Do we do we consider the Otter is sufficient for a member meeting or do we need proper captioning?

Yes, that's exactly what I was gonna ask.

Canella Yeah, I think when when certainly when it comes to our leadership team meetings, we we can probably just make do with with Zoom, but we've membership meetings we probably should have the full the full complement of otter and so forth.

No, no, no, no, his question is not that. His question is on membership meetings. Do we need human captioning?

We should have Yes, I believe so.

Kyle Shulman

So okay, great. Great. That was one of my initial questions. And so Joly Judith with the the vendors are that you've kind of sent off in that email to me. Do you think you could maybe reach what ideally what we would like to have is get a contract in for the first kind of meeting of the member meeting. And then just have an addendum on to that or have a retainer. So for those meetings that you do indeed need that human captioning that we have that I'd love to get that kind of rolling sooner than later. So when you do have your all member meeting that we can have nice

and full job for the captioning, all caps and once you have the initial contract all captioning first needs is we emailed them and we schedule a meeting and then they bill us okay, but so they would have to build you would have to give the information of who they build, because it gets very confusing, because Caption First works often Yellowman a Joly with with ISOC and so sometimes we've had problems where they build ISOC and iSeq paid for us on they failed us and some knees got lost and it took a long time to fix it. Yeah.

And and cause between Judas and Jolie you have two experts when it comes to how the the system works with captioning and captions first so you know they they can help you as much as you need to

Joly had to hand his hand up. Joly on mute

Joly MacFie

but most of the time when I used to book for ISOC for ISOC for Ollie sake for ISOC DC and and so they ended up where a point where they were sending me every invoice. Going. And then you know, you specify to them who you want build, but quite often somehow it doesn't go through lovely and so yeah, you have to be but I mean they have an established vendor relationship with ISOP you know, they're already registered with ISOC as a vendor.

Kyle Shulman

Now that Joly there's nothing in say your the the contract that you have with Christy and the CMC team for any kind of web captioning. It's just strictly for broadcast.

Joly MacFie

We manage the live streams basically. Yeah.

Kyle Shulman

Okay. I was just trying to see if there's any way that we could utilize an existing budget line where we wouldn't have to the budget for caption would have wouldn't have to come out of your budget. So okay, um,

no, I mean, that's me sick entirely separate. That's me as you know, as a contractor to ISOC has nothing to do with this.

Kyle Shulman

Well, that's great news, Judith then that with in regards to the captioning that you basically send them an email saying what you need the need is and then they they fill it so and let's hope that you know the the bill if it does come to you Joly it.

Joly MacFie

Well, I think is we should have a go at capturing first and ask them if they can send us a pro forma invoice. Okay. You know that what that I think would be a good a good practice so that so that, then you know what's coming before before it arrives? Okay. I don't think the words pro forma have ever been used in this context, but it is actually quite an effective business practice.

Kyle Shulman

Yeah, no, I am.

Judith Hellerstein

Right. So we also can do so the only other thing we do, we don't have it. They could. They also can do Spanish. Okay. But we need to have a Spanish interpreter.

Kyle Shulman

Yes. So do that, as I said in my email last last week that the official language of the SIG is indeed English. So anything that you want to do outside of that, so translation, it's more than welcome to but realize that your budget of that 25 to \$30,000 a year yeah, that would be inclusive that so if that is a need, then by all means, go for it. But if you feel that you can utilize funds in another spot, just keep be cognizant of that.

Right I Joly

Joly MacFie

so you're saying there are two different funds, one is admin, which would pay for zoom and so on. And the other is basically your budget for the year, which from which we would do anything that isn't admin, is that correct?

Kyle Shulman

More or less? Yes. So in terms of that, I mean, and realistically, the only admin will be saying your your captioning, the Zoom license, and the otter kind of license. I think everything else was is already covered or primary of ISOC. So going back to the original agenda, so when your questions y'all it was regards to what I thought would be able to supply in terms of the the LS the wikis and such. And from that, or it seems like that the Connect platform is what's going to be that nucleus where you can put the blogs and the events and everything and utilize that as your primary kind of core or where you're going for everything and everything lies. So that's where the archives are going to be and such if you're looking to say utilize social media, then we would connect you with the ISOC kind of channels or the the people responsible for social media to produce or create postings for if you're hosting events or webinars and such as that to advertise for that. But realistically, the primary means for all of the standing groups and six is going to be on Connect.

Of question for you. We also use another form and that is more accessible. We pay like a small license fee each year.

Joly MacFie

This is this is yeah. This is this is the accessible you know, the old accent the New York accessibility sec. You know, I don't think the SG you know, as I understand it, we don't even have any any. You know, when I asked what are the duties of the admin, we don't even approve or disapprove of members that's all you know, my job as the admin is only to like basically be list mom on Connect, and all the membership details are totally out of our hands is that correct?

Kyle Shulman

Correct. And that's just because of GDPR and, and standard groups and things not being legal entities. If they were in that case, then you would have that access to that information much like a chapter, but we need to think of the standard groups and say exactly as working groups and and so that that info isn't there and the criteria for becoming a member of the standard grip. arcic is if you're a global member of ISOC, you're automatically

right. So my question is, how do we get Joly, maybe Joly nosy answer have you the forms that they use for doing webinars or other stuff. Are they accessible? Oh, because we use different ones for printing with

I think we're talking slightly across purposes here. Um, you know, you're talking about setup of events. Kyle, Judith is really talking about access to membership details. I think, you know, and so, you know, we, when people join the accessibility SIG, we have a form which tells us you know, if they have a disability, if they have experience and in practice and all these kinds of details, okay, so this is the kind of thing we'll be lacking when we I mean, we could make a Google form and pointed out the accessibility so I would like to change the subject slightly and say, just keep it on. How do we access our membership? Can we say that everybody who is a member is automatically on Connect? Some of them won't have email, email switched on? Is there any way that we can email everybody who's a member of the SEC?

my Anjali I was also talking about the form you create for webinars with that other system that is more accessible then. Then the Zoom one

what form I'm not really there.

You used to used to do another form for webinars with the the what do we pay that license of \$18?

Joly MacFie

Well, that's that's the Gravity Forms, but we just use it for registration. I think we've only used it for registration.

Judith Hellerstein

Oh, Gravity Forms on grants

Joly MacFie

and people applying for grants and things.

Kyle Shulman

So Joly the the email that I just posted into the chat. That's what every connect group has is their outgoing so if you utilize that say in in an email and send it that goes out to the entire community. That's

Joly MacFie

yeah, that's, that's within Connect, but not everybody. Not everybody has email. You know, people don't.

Kyle Shulman

So this is kind of the chicken in the egg thing with all of the GDPR so for unless we can tether somehow the A UA to allow you access to the emails or do something that way. That's the only way I see it possible or if we get somehow the legal team to have you sign an NDA or some sort like that saying that you're not going to be abusing the data. That's the only thing

Joly MacFie

I would think of preferable is you know, we just have a process where we submit to whoever is our coordinator. We'd like to we'd like to email the entire membership with an announcement, which would be in a situation where we have a webinar coming up, you know, there would only be this kind of thing, where where I thought would take would say, okay, fill out this, fill it out. Here like we used to on the old thing, and then we're going to work so we never actually have to know that membership, but we need to be able to reach our entire membership.

Judith Hellerstein

Not on Connect.

Kyle Shulman

Okay, so I think a solution that would be is say you want to produce so the object is yes, let's get out a form of some sort that every member then can utilize to fill out your experience in the in the community do you live with? Yeah, you would send that to me, and then I would be the one that would give that out to the members, I think.

Joly MacFie

I think we just need an avenue where we can actually Okay, send something out to all our members who aren't I mean, many of these might be half a dozen a year. When we have you know, like a phone like that, or a webinar, but just just connect is not good enough because people Yeah,

Kyle Shulman

no, I understand. Alright, so let's like sending out

Judith Hellerstein

so like, if we want to send out like I suck is doing some training or some laying. Do we send it down a cig it the question is I don't want to use Connect can you connect requires another step? If it can send it out on the SIG leaders, but sick leaders will only meet SIG leaders cariah would like to send out an invite information about his the ISOC classes running on x

Kyle Shulman

okay, so Jared, I think Joly has touched on that solution is you're gonna send that email to me and say, Kyle, can you please send this out to the entire standing group on this to go out and then because I have under the protection of ISOC I'll be able to go into the AMS and then send it through that channel then to ensure that it goes to everyone and as Joly said that it's if it were to go out through Connect, people do not have their emails turned on. So they get they're not going to get that so this is a means to get more time.

Joly MacFie

I think I think in general Kyle, you should have a list of resources for SGS sakes and I'm one of them is this you know, and so we should you know you should be compiling from going with us you know what these things are? And it's just spread it out to everybody.

Kyle Shulman

Okay, no, no that and thank you for that you

Joly MacFie

know the differentiation between Atman and and yeah by

Judith Hellerstein

and then Yeah, cuz because right now we have no way of passing along ISOC information about classes. I

Joly MacFie

mean, honestly, I thought it my socks information is kind of like a socks business. I'm only worried about passing on RSG information.

Judith Hellerstein

Yeah, I'm learning about everything. I'm not and I

Joly MacFie

differ from you and I actually like connect and I use it all the time. Yeah, well, I you know, it's not so bad.

Kyle Shulman

So can we make can we have an agreement though when we do say something that goes out to the all of the community can we also make sure that we have an archive of it or have the announcement Donna and connect as well? Because I think that

I mean, it would definitely go out to our community. You know, we you know, we'll, we'll you know, blast it out on all channels. If we have an announcement. There are certain things where, you know, and we can say you should have you probably have received this email you should have received an email, you know, or on email, we can say you should see you if you're not on Connect, you know, this, you'll be receiving this. I mean, there's no way you can look at your analysis and say, who is you know, not not receiving emails from connect and

Judith Hellerstein

just know that and also I am fairly difficult to connect also, to get attachments, you have to log on to get an attachment. You can't just get it. It's also very bad for people who have heart and I'm not sure how accessible Connect is.

Kyle Shulman

Yeah, um, no and and so do you also Tibbett is come quarter three, we're rolling out the new AMS so fun to have Salesforce. Hopefully that will be the solution where we have something that's a little quite quite a bit more responsive. User friendly, and overall

accessible call. Just make sure to make really sure that it's accessible. It's been tested by real people with disability.

Kyle Shulman

Correct. And, you know, I think you had you guys had the conversation with the communications team and I think that might be a nice avenue for you guys to kind of broach as well. I know that they had said that the first year would be the existing kind of content but then in 2023, it would be more on the the tools and stuff at hand, but I think you might want to I would I would push on the on the accessibility

Gunela Astbrink

I made that point very clearly that if any new tools coming coming in, in the meantime, while the content is being made more accessible, that that shouldn't shouldn't get through without being tested properly. So

Kyle Shulman

great. Timing, you know, because I have a meeting myself with the company that is doing the implementation and creating the user stories for the special interest groups in this and I'm putting that as a major point is the whole accessibility thing that let's push that

Judith Hellerstein

we they often are not tested by companies, they say Oh, yes. Well, we'll look at that. Oh, we had this thing done. We have this thing down. We follow these guidelines, then they're not tested. Yes.

Joly MacFie

Now it's cost. They say could you have a few people look at this and tell us and what we've been responding to them is, this is not the way you do it. You hire professionals who know how to test sites or audit your site.

Yes. Okay.

Yeah, that's the foundation all the time. Al listen to us.

Kyle Shulman

Yeah. All right. Um, so moving along, because we don't have that much time. I want to talk about that kind of action plan and that kind of that and how that's going to come to fruition. So I know that you guys had said that you're going to hold your your calls or whatever and get the team together on the same page and kind of look us up. And I think one benefit of the the scanning group here is that you have experience you've been functional before in previous iterations. So I don't think your your goals per se are going to change to too much in that your area of focus. I mean, you guys are experts in in this area, the templates going to be looking at your activity. So as Julia as as you noted, or said earlier, there's the portion the small portion for the administrative kind of things like your licenses for communications, but the real meat of it is for the activity. So what activities you gonna hold. Are you going to produce any kind of reports are you going to be tethered the activities will be tethered to KPIs are so your overall goal, so looking at your goal, and then your activity, and then the KPI that relate to it and then your target. So I mean that for every single standing group, and STG is going to be the the activity kind of template going forward. So strategically thinking how you go about to create the biggest impact for the standing group. Judith, please.

So let me let's let me go back and see what I can do because yes, I I do see there. It is valuable to have that in that opportunity.

I can just do you know, 50 or something or 20 You know, she just does a small amount. So, there is, you know, there are alternatives that we and it's something that we as a group should look at finding out more about being able to inform people how they go about this.

What are your goals there and then the short term looking at from now until the end of the year. And so the focus really is for the activity portion is to looking at now until the end of the year to develop those activities, the KPIs and the metric targets that you want to accomplish or what is feasible. And so from there with this template, it I encourage the entire leadership team to work on it together. And maybe the planning reporting officers, they're the ones that work as the kind of scribes here and write it or put it together. And then I'll be working with you all to kind of go through it and see if there's anything that is missing or if we can find tailor it and then we'll be using the the working group that kind of worked on the new iteration of the six of the new template and then inviting a couple other people or I guess John Moore was involved in working group to begin with but a couple of figures in the ISOC community that can provide some insights there. They're not going to be saying, Alright, there's a plans approved or anything like that, but they're just here to provide feedback or because of their past experiences that they utilize. But I'm very confident here because you guys have all this is not your first rodeo. You're all proficient in ISOC you're all very I think you're well respected. You understand what running a special interest group or experience running the chapters is like, so I have full confidence in you all to produce something that's tangible and actionable for the year.

Judith Hellerstein

My question is just like jollies question, what does the treasurer do now that we are

so you remember are so I suppose with the treasurer's role, if you are going to go down an avenue right creating that partnership with the New York chapter or any kind of third party organizations, if they're gonna provide income contribution, I mean, you'll be taking track of that and being able to inject it into the meetings or whatever. So that's the opportunity there. If there are external partnerships that involve in kind contributions, you'll be facilitating those and then making sure that you know, I'm informed or Christine's informed of that, like

also working with the AI, the IGF and that type of thing.

So like the DCad and all that other stuff and or IGF is I curiosity

never gone from the Oh, in Yes. Okay, so what i Okay, so what he's saying is that I jfsa Does fun transcripts. For IGF mag meetings, okay.

But they also do from time to time, provide funding say for webinars if

I'm no no that would that say IGF as the as the FSA funds, IGF? Um,

Gunela Astbrink

no, no, we're talking about IGF I say

Judith Hellerstein

I say has a fund that helps just like ISOC in the foundation has a fun that helps national groups put on IGF? Okay. I gssa. But they only give funding to developing countries.

Kyle Shulman

Yes. Well, because like when I was running, I was just curious. I was just curious to see if it was still the same thing because I know when I was still running the secretariat that we provided the stipends to get I think we're good now that we got you to Guadalajara through the jfsa. If I recall or so do we do they still do anything of that or is that no longer?

Judith Hellerstein

No, no, they do not. Marcus doesn't they lock us doesn't have funding for that.

Kyle Shulman

I gotta shake Marcus up that and get get that funding back for everyone. There

Joly MacFie

was some funding that comes through from Google right and Google to us to fund we have funding

Judith Hellerstein

for we have funding from Google to decad to help people with disabilities come to events.

Kyle Shulman

Okay. Is there any way that we can ask Vint for any kind of funding for the standing group or is that is he adverse?

Gunela Astbrink

Look, I think we should probably separate that. I mean, I asked I asked him personally for that funds of it for the cared, and that was specifically for ensuring that the voice of persons with disability was heard at IDF and that was through travel. But during COVID It was for support for broadband and also in developing computer hubs like chindi is on the call. And and he ran to computer hubs. So that's quite different, but there is a possibility so so no, I don't think we should we should involve the into in the standing group trying to get funding I think that we should keep that separate for for some, some particular particular other other issues. So we don't we don't get muddy the waters too much. Yeah. But I think we have IGFs say that there is a possibility maybe there we could get support for sign language interpretation, for example, if needed through webinars, so that's maybe where we can get get assistance. Interesting.

other thing he we got another possibility. What we've also been using the DCad fund up this funding that he gave to DCad is for DCad. For our annual event, we've been funding that the internet the translation, the sign language, interpretation and International Sign Language.

On that, Judith, with in regards to the human captioning, you had proposed the ASL or iSL for the meetings as well. Is that something that you would,

Judith Hellerstein

I said that I said that we should have not necessary for membership meanings unless it's needed. I think what happened is it is that is that we should put out a notice for our members and say we will have captioning but also please let us know. What if you acquire sign language and what sign language you will require so that we

Kyle Shulman

could you use it so using the the the workflow that's been proposed where you guys so said the member meeting is scheduled? You you send me the details for that and then I will send a note out to the entire accessibility standing group community could you guys also had that say a survey or attach form to that asking that question so that we could kill two birds with one stone and then if that's needed, then we

Joly MacFie

removed the normal process and I'm thinking of, you know, the FCC if that's, you know, but, but uh, you know, you say, if you have any special requirements, please email this address, and it isn't usually a

form, it's usually email and you initiate a conversation, you know, about about what can what can't be can't be done. Okay. So that's, that's the normal normal best practice.

Kyle Shulman

So in terms of that, then would that be something that I say Joly, would you be willing to be that backstop

comes that comes under admin, right?

And so so the thing is, we when we did a contract with the vendor in New York, they offered a lot of different options but they didn't offer ISL because as I understand that ISIL is not a real it's not an actual language.

Who would it be for would you they be added to the chapter delegates or would it be say someone that's part of the StG that is as special accommodation like what would they ask me? Yes, to add them to everything that you will have access to? Or?

So I think by creating that this clear kind of statement on what the the standing group is about, and then we can list the the officers as well and kind of give you guys a spot on the ISOC website, have what you are and be able to highlight the work as well and create those connections because it's one thing that I've been getting kind of pushback on is that everyone's like us connect us connect but there's connectors for the the ISOC community or people that are members of a soccer club. There's that whole external community where you're trying to create that game or get people to understand all the hard work that you're putting into, and that's the other side of the kind of

our volunteers we have is we have the existing sick, you know, which which we have a wiki you know, we have a website. And I mean, it's my intention is, you know, is to document what's happening in ESG. With you know, with the SEC and this is part of our, you know, the the existing the previous SEC is going to, you know, continue and support the ESG and everything that it does and we see two advantages in this and one is that the SG can make an action plan, which is narrow and can work towards that purpose. And, you know, other stuff which like supporting DCad and this kind of thing, we can retain in the old group, you know what I mean? And so,

are legal and we were Yeah, we're a legal entity.

I will be going and making sure that everyone is able to access the chapter delegates list. And then I will reach out to Pierre John and ask him about the the proxy once again are saying what what the deal is that we have Christine is as well reach out to shamsudeen because you know, she's been able to actually make contact with him. I believe the rest of us haven't had as much success. So let's see if I can help or she can help kind of facilitate that and see what the action is there because it would be nice for him to join today, as we tried.
