Internet Society Accessibility Standing Group 2023 Activity Report

Introduction

The Internet Society Accessibility Standing Group (ASG) was formed in 2022 and has completed its second year of operation. The leadership team has held monthly zoom meetings to plan and organise activities.

A key milestone was the Board of Trustees Resolution on a Policy on Accessibility for Persons with Disability in April 2023. This was initiated by Dr Muhammad Shabbir, a BoT and ASG member. This dovetailed very well with the ASG's work on the ISOC Accessibility Framework in collaboration with the ISOC internal working group on accessibility.

Below is the annual report that outlines the ASG's activities in 2023.

Vision

Our vision is digital inclusion for persons with disabilities.

Goals

Long-term goals

To change perceptions of stakeholders so that accessibility is addressed right from the start, eliminate barriers and create new advocates for continuous improvement of accessibility in the internet ecosystem.

Goals in 2022-23

- Build understanding on accessibility through:
 - partnerships with ISOC chapters and other key organisations
 - training and mentoring
 - promotion and communications
- Implementation of a pilot program aimed at training emerging leaders with disabilities
- Improve digital inclusion for persons with disabilities in the Internet Society.

Planned activities as defined in the action plan

1. Ongoing liaison and cooperation with ISOC staff on ensuring the accessibility of ISOC content, policy and practice.
2. Build partnerships with ISOC staff, Chapters, SIGs/SGs, disability and non-profit organizations, NRIs, and Schools of Internet Governance.
3. Develop an interactive online course for training emerging leaders with disabilities about Internet governance.

4. Communications campaign targeting different stakeholders such as businesses, web/app designers, developers, project managers, education community and policy makers.

Projects

I. Disability Leadership Training in Internet governance and digital rights

Community Consultation on Content Development of Disability Leadership Training in Internet Governance and Digital Rights (January)

Recognizing the need for more disability leaders in Internet governance (IG) and digital rights, the ASG decided to develop content for an online course on disability advocacy and targeting IG practitioners and trainers who wish to know more about Internet accessibility for persons with disability. For this purpose the ASG organized a community consultation on the content development of the course. Speakers and facilitators included persons with disability, IG practitioners and trainers from the Internet Society, IGF and ICANN communities.

Course Syllabus (February):

Based on the input from the community consultation and the expertise of Nirmita Narasimhan with advice on content and structure from the ASG Chair, Gunela Astbrink, a course syllabus was developed for the promised ISOC e-learning course.

Mentorship of 2023 IGF DCAD Fellows (October):

As the basis for an informal partnership between the ISOC Accessibility Standing Group and the IGF Dynamic Coalition on Accessibility and Disability, Gunela Astbrink offered to mentor DCAD Fellows traveling to participate at the IGF in Kyoto, Japan. Gunela self-funded her travel. Vidhya Y (India), Grace Salanje (Malawi) and Nicodemus Nyakundi (Kenya) were the initial DCAD Fellows from outside Japan. Unfortunately, Grace Salanje was unable to obtain a visa in time and therefore could not travel. Lidia Best (UK) was able to take up the Fellowship at short notice.

Outcomes:

Both Vidhya and Nicodemus were encouraged to take on leadership roles in the ISOC Accessibility Standing Group.

Online course development (November onwards)

ISOC agreed to fund the online course in November 2023 with meetings held by Gunela Astbrink with ISOC e-learning staff and the online course development contractor. The online course will be a model of e-learning accessibility. This development is being carried through to 2024.

Pakistan disability leadership training workshop (26-28 December)

Based on the model of the Dhaka workshop and with ISOC ASG funding, a Pakistan disability leadership training workshop was organised and supported by Pathfinder Solutions and the Pakistan Telecommunications Authority (PTA). The Chairman of PTA was a special guest in the closing ceremony and is interested in recommended accessibility measures for potential implementation.

Sri Lanka disability leadership training workshop (30-31 December)

Based on the model of the Dhaka workshop and with ISOC ASG funding, a Sri Lanka disability leadership training workshop was organised and supported by the Lanka School of Internet Governance.

Key outcome: Both the Pakistan and the Sri Lanka workshop organisers identified potential leaders in Internet governance and digital rights. The organisers will encourage them to continue their learning, apply for Fellowships and participate actively in Internet fora.

ISOC e-learning tutor guidelines (November 2023-January 2024)

Recognising that ISOC e-learning tutors need increased understanding of the accessibility needs of persons with disabilities when undertaking ISOC courses, ISOC ASG funded Pathfinder Solutions in Pakistan to develop tutor guidelines. The project contractors participated in a meeting of ISOC tutors explaining the project and following up with a key tutor as well as consulting with Vidhya Y and Vashkar Bhattacharjee who have done ISOC courses. The tutor guidelines are in draft form.

II. ISOC Disability Inclusion Action Plan

In 2022, the ASG drafted the ISOC Accessibility Framework to outline in broad terms suggested areas that the Internet Society may improve its

policy, programs and activities to meet the accessibility needs of persons with disabilities. The two main objectives were to:

- build a culture of accessibility
- minimise barriers to participation

The Accessibility Framework was developed in collaboration with the ISOC internal working group on accessibility.

After the Board of Trustees Resolution on Accessibility for Persons with Disability was passed unanimously in April 2023, the ASG developed a Disability Inclusion Action Plan based on the two main objectives outlined in the Framework. It specifies in more detail each of the recommended actions, the responsible section, timelines and reviews. This Action Plan will continue to be discussed with the internal working group in 2024.

Asia Pacific School of Internet Governance (APSIG), Philippines (November)

Gunela Astbrink was a member of the APSIG Fellowship Committee. Two fellowships are reserved for persons with disability.

An integral part of the annual APSIG program is accessibility and disability inclusion. Gunela Astbrink, Manique Gunaratne, Vidhya Y and Eshaq Buyhan presented in the 1.5 hour session.

In the feedback session, at least six Fellows stated this was their favourite session or referred specifically to it. In addition, several people spoke to Gunela directly afterwards that they will follow up with their organisations to:

- alert developers to WCAG

- use Universal Service Obligations through the telecom regulator to provide services/support for persons with disability
 - make sure that persons with disability are included in workshops on misinformation/disinformation
 - include digital literacy training for persons with disability in remote areas
 - reach out and include persons with disability in a gender-based program
- prioritise studies in disability policy

ISOC Chapters needs assessment (July-September)

The Accessibility Standing Group in collaboration with ISOC Foundation conducted a survey to assess ISOC Chapters' needs for promoting digital accessibility and their knowledge and readiness in terms of digital inclusion.

This survey aimed to bridge the information gap concerning the ISOC Chapters' priorities as well as human and institutional capacity needs with regard to accessibility for persons with disabilities. It also aimed to determine whether there are

needs/interest in offering specific grant funding to the Chapters in order to promote and improve accessibility for persons with disabilities.

- The survey found that Chapters were keen to do more on accessibility but needed resources for training and other support.
- The ISOC Foundation can have a role to play in Chapter funding to incorporate accessibility. This will be investigated further with the Foundation in 2024.

ISOC ASG Members' Survey (October-November)

The distinction between 'accessibility' and 'access' is not readily understood. To remove that confusion, the ASG brainstormed two solutions: changing the name or adding a slogan that highlights the group's mission. The goal of the survey was to gather member's opinions about these proposals, as well as collect their suggestions. The survey also aimed to learn more about members' particular area of accessibility interest or expertise.

Outcome: The survey results show a preference for keeping the name and adding a slogan. The ASG resolved to add 'Promoting inclusion for persons with disabilities' to the name.
